

### THE VISION FOR NORTH SIDE IN 2011

#### INTRODUCTION

The Planning Department and the Central Planning Authority initiated the review of the Development Plan 1997 in spring of 2001. The first stage of this review was the creation of volunteer District Subcommittees (DSC) in each of the five districts of Grand Cayman. These DSC were made up of volunteers who have an interest in the future development of their districts, and a vision for this development.

This document represents the vision statement for the North Side DSC. It is a very broad, general document, which gives an overview of the subcommittee's hopes and dreams for the future development of North Side. It is not intended to be a definitive blueprint, or a zoning guide. It is intended to paint, with broad brush-strokes, a picture of the future development of North Side.

The members of the North Side DSC hope that they have captured the vision of the people of North Side, and look forward to working with all the people of North Side to turn this vision into a reality.

#### PROCESS TO DATE

Volunteers were recruited at public meetings in May 2001. The first meeting of the DSC took place at the Planning Department on May 20<sup>th</sup>, 2001. At this meeting, members were given information packages with visioning workbooks to assist them in their preparation for the brainstorming session at the second meeting. The DSC then held a public meeting to present the results of their brainstorming session and to ask the public if they had covered all of the issues of importance. Based on this public input and input received from their friends and neighbours, the DSC then ranked the overall issues and the points under each issue. The results of this ranking can be found in Appendix 2 of this report. The committee met to review and discuss these ranking results, which led to the vision statement contained in this document.

The volunteers who have worked on this vision report are listed in Appendix 1. The DSC has appointed Mr. Derrington "Bo" Miller to serve as the North Side representative on the Development Plan Review Committee (DPRC), with Mr. Shayne Howe to act as his Deputy. The volunteer members of the DSC hope that the work started in this process can be carried on and plan to continue to meet informally throughout the Development Plan Review.

#### NORTH SIDE'S VISION FOR 2011

#### BY 2011, NORTH SIDE WILL...

In 2011, North Side is a beautiful, tranquil district that is envied for its natural beauty. The people of North Side recognize the value of a good neighbour and have seen a strengthened community. It is not unusual to witness North Siders working together to help a neighbour, and this community spirit is contagious. The important link between economic development and the health of the natural environment has been recognized by North Siders, and this is evident in the recent development in the district. A District Action Committee of community volunteers plays an important role in the development of North Side, ensuring that the best interests of the district are considered first and foremost in the development process. More and more North Siders are moving back to the district, further evidence that North Side's beauty and tranquility makes it the district that people want to call "home."

The beauty of North Side's natural environment and the associated tranquility is the "money in the bank" that will draw people to North Side.

#### THE NATURAL ENVIRONMENT

In 2011, North Side is still a district that has been blessed with a great deal of natural beauty. From the beautiful blue sea to the rich mangrove wetlands, the people of North Side have continued to take their role as stewards of the land very seriously. North Siders have worked to preserve the district's environmental wealth so that it can be passed on for their descendents to enjoy and cherish. This has been achieved, in part, through the following:

- Proper wastewater management is part of all new developments, and existing development has been encouraged to embrace good wastewater management principles.
- The issue of the zoning of the Central Mangrove Wetlands has been resolved through extensive negotiation with affected landowners. The important balance between property owners' rights and the need to protect the environment has been the basis of these negotiations, and the affected property owners have been given a voice in the process.
- The Mangrove Buffer zone has been reviewed island-wide. This review has included ensuring that the Mangrove Buffer zoning in North Side is consistent with the rest of Cayman.
- The water lens has been protected through careful planning and regulations governing development on it.
- The natural environment is an important consideration in the economic development of the district.

#### ECONOMIC DEVELOPMENT

By 2011, North Side has continued to experience moderate economic development, which has kept pace with the needs of the residents of North Side.

- The important link between the health of the natural environment and continued economic development has been recognised and all new commercial development has been held to high standards to minimise impacts on the natural environment.
- New commercial development has been designed and built to respect the existing character of the district, fitting in with respect to scale and massing.
- Although there has been continued commercial development in North Side, it has occurred in a balanced way so that the tranquil nature of the district has not been disturbed.
- North Side has taken advantage of its natural beauty and tranquility and taken the lead in developing and promoting Ecotourism in Cayman. This has been possible due to the development of North Side's open space network, and the construction of amenities such as picnic areas and nature trails.
- North Side has also seen the development of "cottage industries" such as thatch and craft shops and food stalls. These cottage industries enjoy serving the residents, but have also capitalised on the increased number of tourists that has resulted from the growth of tourism.

#### PUBLIC SAFETY

In 2011, North Side continues to be a safe district that is desirable to live in due to:

- Community leadership and role models continue to play an important role in the community.
- The incidence of drug usage, and drug-related crime, has been reduced through effective community involvement and cooperation with the RCIP (e.g. through the introduction of modern technology, such as roadside cameras).
- Strict guidelines and regulations regarding the importation and use of hazardous chemicals used in agriculture and horticulture have been enforced, resulting in zero incidents of accidental poisoning.
- There are ample activities and alternatives targeted at the young people of North Side to encourage their active involvement in the community (e.g. Junior Achievement, kayaking, sailing, diving, Scouts, etc.).

#### SOCIAL DEVELOPMENT

North Side people pride themselves on their involvement in planning the growth of the district, which is evident in their continued input to the planning process, including the development of a District Action Committee made up of citizen volunteers. This input is aimed at ensuring that all the people of North Side are considered, especially the youth and the elderly. People of North Side know and understand the value of a good neighbour, and are always there for their neighbours in need. North Siders also understand that the diversity of the community is one of its greatest

strengths, and work together to ensure that all residents of North Side are welcomed as neighbours.

#### HOUSING

North Side continues to be a desirable district to live in for those who have roots there, and for those hoping to find their own tranquil place to call home. In 2011, housing development in North Side can be characterised as follows:

- Housing development in North Side is predominantly single family homes, which includes opportunities for affordable housing.
- Housing development continues to respect the existing character and natural beauty of the district.
- New residential development in North Side has extensive native landscaping, made possible through the retention of as much existing vegetation as possible when building.
- Planning regulations have been changed and financial assistance programs have been initiated in order to enable sufficient affordable housing to allow young North Side residents to stay in the district.
- Affordable housing has also been made available through community members helping each other and assisting in house construction.
- The planning and construction of a community retirement facility for the elderly residents of North Side.

#### RECREATION FACILITIES

North Side is envied for its extensive open space network, including beautiful public beaches. The public beaches have excellent facilities including adequate parking, picnic tables, shade trees, toilet facilities, and gazebos. Public picnic areas, bike paths, and nature walking trails are an integral part of North Side's open space network and form the backbone of its successful Ecotourism industry.

#### POPULATION GROWTH

The continued gradual population growth in North Side has been in part due to more young North Side residents and families continuing to live in the district, rather than leaving for other districts. Those residents that left North Side are encouraged to return to the district. Additionally, people continue to move to North Side to take advantage of its natural beauty and tranquility. Sufficient residential lots have been made available to accommodate this gradual population growth.

#### TRANSPORTATION

North Side has benefited from a reliable public transport system, giving greater, more efficient access in and out of the district. Through careful road network planning, North Side has been able to accommodate economic development without the increased traffic congestion that usually comes with it. The road network has provided greater access to the undeveloped areas of the district, which has facilitated appropriate development in these previously inaccessible areas. A more direct route to George Town has been constructed, with minimal negative impacts on the Central Mangrove Wetlands.

#### CULTURAL AMENITIES AND HISTORIC SITES

The Civic Centre is a focal point in the community, with regular sessions of programs teaching historic skills and lore to the residents of the district. In these programs, the elders of the district pass on their skills, knowledge and experience to the younger generations. North Side continues to be a district that is extremely proud of its heritage, and celebrates this through a number of cultural programs. The Historic Buildings Register contains information on the many historic homes in the district. Many of these older homes have been preserved and provide links to North Side's past, helping to bring the rich history alive for the young people of the district.

#### CIVIC BUILDINGS AND SERVICES

The schools and Civic Centre have become the focal points of the district, with extensive programs for all residents of North Side, with a particular emphasis on the youth and the seniors. The cultural education programs are supplemented with retraining and continuing education programs, making the civic centre a hub of activity. The open space network that Government has worked to formalise has been developed with amenities through public-private partnerships. The nature trails, picnic areas, and public beaches are enjoyed by visitor and resident alike.
